**ELIGIBILITY FOR NOMINATION**

- 1. All nominees will have a short interview with the Appointments Committee prior to polling to ensure that nominees are suitable to act as a Student Trustee.
- 2. No person shall be eligible for nomination unless they are a registered student of the University of Hull and will remain so for at least one academic year following election.

If answering "Yes", a nominee will be required to declare any criminal convictions confidentially to a panel (comprising the Human Resources Manager, the President and two Student Officers). The type of conviction which may lead to disqualification is the same as prescribed in the Student Officer Code of Conduct. Failure to declare a conviction prior to election will automatically lead to disqualification if it then appears on the subsequent CRB form which is applied for after election.

- 4. **NOMINATION FORMS** Nomination forms for Student Trustee positions are to be submitted by all candidates by **XX**. The form is divided into two parts.
  - a. Part 1 Part 1 of the form shall contain information detailed below, typed or hand written in black or blue ink without any additions or embellishment:
    - (1) The full name and consent to nomination (signature) of the candidate.
    - (2) Photograph of the candidate not exceeding two inches by two inches, showing full face, head and shoulders only.
    - (3) Biographical details. University course, year of study and student status.
  - b. Part 2 Part 2 may be used by the candidate to give reasons for standing. The form is not to be cut or adapted in any way nor is the size to be increased by the use of embellishments. Candidates are advised to read the Student Trustees candidate pack before completing this section. The role of a Student Trustee is different to that of a Sabbatical (Student) Officer.
