3 University Matters

HUU invites guests from the University to engage Course Representatives with projects and plans, and for feedback.

i) Timetabling (Helen Kirby-Hawkins, Senior Timetabling Officer)

Course Reps were invited by the VPE to provide quality feedback on the student experience regarding timetabling. Feedback included inaccuracies and lectures cancelled or re-scheduled without warning.

Some reps asked for timetabling to work with Google calendar – VP-E replied that everyone uses different formats. It was suggested that students receive a text to indicate last minute cancellations; this was warmly received by other reps. The timetabling team asked students when they would like the release of the semester 1 timetable. The common consensus was

- ii) Technology Enhanced Learning – Andy Birch, Canvas Project Manager (Monday); Joel Mills, Acting Head of Technology Enhanced Learning (Tuesday).

The general consensus was that students are happy with Canvas. AB explained to students how they can cut down on notifications should they wish. AB also encouraged students to use the 24/7 helpline. Many students raised the issue of relevant and important documents on eBridge not being transferred to Canvas. AB explained that these documents have not been lost and can be transferred over. JM talked about the possibility of de-anonymising exams and assessments so academics will know whose work they are marking. This will enable staff to administer personalised feedback and will be beneficial for staff and students alike if staff are able to say well done to students. Some students raised the issue of favouritism or those who have complained about a lecturer being punished through a poor mark. It was suggested that a combination of both might be beneficial: staff can find out students' grades after they have been administered.

JM also discussed digital exams, which would be composed of large rooms full of computers with a locked down browser so internet usage is restricted. TEL are currently considering multiple scenarios in how this would look. The benefit of digital exams is that the system can automatically mark students' work, meaning the workload for academics is lightened and students will get their feedback much quicker.

iv) SLTA Update

VP-E thanked those reps for their help in making the launch of the SLTAs a great success. In one day we received 205 separate nominations – a record. Those reps will get course rep points.

5 Other Course Rep Matters

Course Reps were concerned about the staff at Sanctuary who tend to talk to each other and ignore customers. Reps were also concerned over the price of goods in the shop, which were deemed to be too expensive. VP-E explained that the shop will soon be a Spar, which will be convenient for everyone.
