## STANDING ORDER GOVERNING THE POST OF PRESIDENT OF EDUCATION

### 1. Interpretation

These Standing Orders shall be read in conjunction with the Articles, Bye Laws and the relevant Standing Orders of Hull University Students' Union and shall be interpreted accordingly.

### 2. Status of Officer (President)

The President of Education shall be a Principal Officer of the Union; a Trustee of **Hull University Students' Union** and shall be a voting member of the Union Executive Committee. The President of Education shall be responsible for the academic representation and support of students at the University of Hull. The President of Education is head of the Education Zone and is to liaise with its officers on a regular basis.

### 3. Election

The President of Education shall be elected in accordance with Hull University Students' Union election regulations.


### 4. Duties

The President of Education shall fulfil those duties and obligations that arise consequentially upon signing the contract of employment for the post of President of Education.

In representing Hull University Students' Union's members, the President of Education shall regularly report on progress through various media platforms including student media with particular emphasis on the successes achieved for both individual and groups of students.

Particular duties shall include:

- a. Representing students on academic issues;
- b. Engaging with students on a regular basis;
- c. Supporting Part-time Officers and fellow Presidents with their projects;
- d. Leading the Education Zone and supporting Faculty Reps, Deputy Faculty Reps, Postgraduate Faculty Reps and Course Reps;

- e. Promoting the appointment of Faculty Reps, Deputy Faculty Reps, Postgraduate Faculty Reps and Course Reps;
  - f. Consulting with the student body on education issues that affect students on a local and national level with reference to changes that could impact upon them;
  - g. Campaigning on education issues that affect University of Hull students;
  - h. Organising the Education Zone Open Meetings and Education Zone meetings;
  - i. Working with the Membership services team to ensure training for student volunteers including Part-time officers is relevant and effective;
  - j. Attending all relevant University Committee meetings and ensuring student representation on all relevant working groups;
  - k. Running campaigns on student issues and assisting in campaigns that other Presidents may be running;
  - l. Working as part of a team with relevant Hull University **Students' Union** staff on issues affecting the student body;


## 5. Internal

The President of Education shall be:

- a. Chairperson of:
  - I. Education Zone Open Meeting.
- b. Voting Member of:
  - I. Board of Trustees;
  - II. Union Executive Committee;
- c. Ex-officio Member of:
  - I. Education Zone.

## 6. Finances

The President of Education shall be:

- a. Responsible for overseeing the Education zone budget working with the Membership services team.
  - b. Responsible for President of Education budget in line with the financial delegations framework.
  - c. A signatory in the capacity as a Trustee as set out in the financial delegations framework.
