STANDING ORDER GOVERNING THE POST OF PRESIDENT OF SPORTS

1. Interpretation

These Standing Orders shall be read in conjunction with the Articles, Bye-Laws and the relevant Standing Orders of Hull University Students' Union and shall be interpreted accordingly.

2. Status of Officer (President)

The President of Sports shall be a Principal Officer of the Union; a Trustee of Hull University Students' Union and shall be a voting member of the Union Executive Committee. The President of Sports is also the President of the Athletic Union. The President of Sports shall be responsible for, the provision and representation of Sport at Hull University Students' Union. The President of Sports is head of the Sport Zone and is to liaise with its officers on a regular basis.

3. Election

The President of Sports shall be elected in accordance with Hull University Students' Union election regulations.


4. Duties

The President of Sports shall fulfil those duties and obligations that arise consequentially upon signing the contract of employment for the post of President of Sports.

In representing Hull University Students' Union's **members**, the President of Sports shall regularly report on progress through various media platforms including student media with particular emphasis on the successes achieved for both individual and groups of students.

Particular duties include:

- a. Representing students on sports-related issues;
- b. Engaging with students on a regular basis;
- c. Supporting Part-time Officers and fellow Presidents with their projects;

- d. Running campaigns on student issues and assisting in campaigns that other Presidents/Part-time Officers may be running;
 - e. Liaising with, and where appropriate negotiating with, the University of Hull Sports Centre on a regular basis;
 - f. Contributing to training of student volunteers and Part-time Officers;
 - g. Liaising with the relevant Hull University Students' Union staff member to organise AU Council meetings;
 - h. Liaising with the relevant staff and volunteers in organising Varsity, AU Ball and the annual Trophy Presentation;
 - i. Liaising with the relevant staff at Hull University Students' Union to ensure the safety and legality of all AU activities;
 - j. Liaising with the relevant staff at Hull University Students' Union to ensure Hull University Students' Union holds all the insurance policies required by the AU;
 - k. Publicising the AU and Sports both within the student body and the wider community;
 - l. Working as part of a team with relevant Hull University Students' Union staff on issues affecting the student body.

5. Internal

The President of Sports shall be:

- a. Chairperson of:
 - I. Athletic Union Council;
 - II. Trophy Presentation Committee.
- b. Voting Member of:
 - I. Board of Trustees;
 - II. Union Executive Committee.
- c. Ex-officio Member of:
 - I. Sport Zone.



6. Finances

The President of Sports shall be:

- a. Responsible for overseeing the Sport Zone budget working with the Membership services team.
- b. Responsible for President of Sports budget in line with the financial delegations framework.
- c. A signatory in the capacity as a Trustee as set out in the financial delegations framework.
